<p>Any adult supervising youth and/or handling troop money at any time must be a qualified GSNorCal volunteer. Girl Scout volunteers must meet the following requirements:</p> <ul style="list-style-type: none"> <li>• Register as an adult member of Girl Scouts.</li> <li>• Complete a Live Scan fingerprinting background check.</li> <li>• Complete 636 GSNorCal Mandated Reporter training, including uploading a certificate of completion for the CA state mandated reporter training, and all training required for their role.</li> </ul> <p>Adults who are not qualified GSNorCal volunteers may be present at troop activities so long as they are not responsible for youth members (other than their own child) and/or troop money. They cannot be counted in the adult/youth ratio but they may assist the troop in other ways including: meeting preparation; subject matter expert/guest speaker; planning; scheduling/organizing activities. They are always able to drive and supervise their own child.</p>
